MINUTES Monthly Board Meeting Monday, April 27, 2015 at 7:00 pm

1. Call to order

The monthly board meeting of the Fox River & Countryside Fire/Rescue District was called to order at 7:00 pm on the 27th of April, 2015 at Station 3, District Meeting Room, 34W500 Carl Lee Rd., St. Charles, IL 60174 by Board President Jim Gaffney.

- a. Roll call Present at the meeting were: Trustee's Dunham, Gamboa, Handley, Jeglum, and Pres. Gaffney, Chief Benson, James Howard, Mary Ryan, Attorney Shepro.
- b. Pledge of Allegiance Pledge was said.
- 2. Public Comment None

3. Reports - Committee Reports

- a. Financial Report James Howard, Governmental Accounting Inc. provided his monthly financial update/review for the last 11 months.
- b. Administrators Report Mary Ryan gave a brief report on the IFSAP Conference she had recently attended. Leadership and Conflict Managing were the main topics discussed. Also, Attorney Shepro reviewed election results, as well as, stating that the board members that have been re-elected will be sworn in at the next meeting.
- c. Chief's Report Chief Benson listed new certificates that have been achieved by a number of FF/PM. He also reported on the Crude Oil training we had recently attended. Chief reported that we have received a FEMA Grant which will cover new SCBA gear. We are busy getting ready for the Pancake Breakfast on May 3rd, as well as our spring "Safe at Home" projects. Wasco Sanitary has reported that they will be waiting a year, or so, before painting the tower. A brief report was give on the recent garage fire that Red, Station 3 attended. We have received the "Call of the Month" from Presence St. Joes on our efforts, in the response to a call where the person was suffering from a stroke. Chief reviewed the information on stroke care received at MABAS Div 2 drills. Also, there was brief discussion regarding the issuance of Norcan, and a life saved.
- d. President's Report President Gaffney reported on the failed referendum and thanked Chief Benson, Trustee Handley, Attorney Shepro, and the many Citizens that assisted in trying to get information to all the residents. He also suggested that the Board review the current sprinkler Ordinance, stating that there is new material (Attic) available. Also, regarding NIAF bill, stated that we need to make our position known.

The purchase or lease of real property for the use of the public body, including meetings held for the purpose of discussing whether a particular parcel should be acquired.
