Personnel shortages caused Station #1 to be understaffed resulting in Ambulance 1851 to be out of service 8 days last month. Two very active part-time employees have each asked for a leave of absence which creates significant voids in manpower. The failed referendum has had a negative impact on stability. The jail continues to be a significant strain on resources.
