## MINUTES

Fox River & Countryside Fire Rescue District - Monthly Board Meeting Station 1 – 34W500 Carl Lee Rd., St. Charles, IL 60174 Monday, July 26, 2021 @ 7:00 PM

- 1. Call to Order President LeBlanc called the July 26, 2021 monthly meeting of the Board of Trustees of the Fox River & Countryside Fire Rescue District to order at 7:15 PM.
  - a. Roll Call
    - Present: 5 Trustees Karr, LeBlanc, McManus, Parthun, Wegman

Also Present: Fire Chief John Nixon, Assist Fire Chief Bert Lancaster, Attorney Kenneth Shepro, James Howard with Gov. Accounting LLC, Tracy Dunklau Administrative Assistant, staff and residents.

- b. Pledge of Allegiance: Recited at Public Hearing.
- 2. Public Comment: None
- Recognition Ceremony A Recognition Ceremony and Proclamation for Successful Efforts of Lifesaving Event took place at 6:30 PM (Prior to the Public Hearing and out of order) for a near drowning incident on June 16, 2021. Patient and Family, FRCFR Firefighters/Paramedics, KaneComm Dispatcher, Campton Hills Police Officer and Kane County Sheriff were all recognized.
- 4. Reports:
  - a. Financial Report James Howard with Gov. Accounting, LLC provided the June 2021 monthly financial reports.
  - b. Chief's Report Chief Nixon presented the June 2021 detail report. He also reported the District responded to 172 incidents which is a significant increase over last year. The Chief announced the new radios are now in service. Trustee Wegman stated for the record, 2019 was a record year for call volume, 2020 set a new record for call volume and so far in 2021 the call volume is 20% ahead of that pace. We are managing with what we have due to the ongoing efforts of the staff we have employed.
  - c. Assistant Chief's Report Assistant Chief Bert Lancaster gave a detailed report on the Heritage Oaks 5 alarm structure fire including challenges due to simultaneous fires in surrounding communities which used many of the same resources. He commended all crews who did an outstanding job fighting the fire. Crews are completing the installation of equipment and hose on the new Mini-Pumper 1834. All ALS paperwork has been submitted to Delnor and IDPH for the new squad. AC Lancaster, BC Sutherland and Trustee Wegman will meet with Campton Hills Village to develop a partnership for new business inspections and procedures.
  - d. Attorney's Report Attorney Shepro reported Kane County is continuing to compile information for the distribution of federal funds. He confirmed that while the District is seeing an increase in calls, the sheriff and coroner is also reporting record numbers of calls.
