- b. Ord. 2015-01 Moratorium on Personnel Hiring & Replacement. Trustee Jeglum moved, Trustee Dunham seconded to rescind the original moratorium. Discussion was had. Litigation, when an action against, affecting or on behalf of the particular public body has been filed and is pending before a court or administrative tribunal, or when the public body finds that an action is probable or imminent, in which case the basis for the finding shall be recorded and entered into the minutes of the closed meeting. 5 ILCS 102/2 (c) (11) The appointment, employment, compensation, discipline, performance, or dismissal of specific employees of the public body or legal counsel for the public body, including hearing testimony on a complaint lodged against an employee of the public body or against legal counsel for the public body to determine its validity. The purchase or lease of real property for the use of the public body, including meetings held for the purpose of discussing whether a particular parcel should be acquired. Roll call: Ayes (5) Jeglum, Dunham, Gamboa, Handley, Gaffney; Nays (0). Motion carries. Entered into closed session at 8 pm.

Board returned to open session at 8:27 pm. The Board discussed the meeting schedule for next week. Board decided to hold a special meeting at 6:30 pm on Monday, before the regular meeting and hold a special meeting at 6:30 pm on Tuesday, August 25, 2015 for discussion and possible action relating to personnel matters.
