- 4. Reports Committee Reports
 - a. Financial Report: James Howard, Gov. Accounting, LLC gave the monthly financial presentation. The Budget and Appropriation Ordinance is being drafted. Fire Recovery remains strong and is now the third highest income for the District. The Chief commented that the District is still waiting to hear on radio grant.
 - b. Chief's Report: EMS service will be switched to Delnor Hospital officially on July 1, 2017. Chief has reviewed plans with Village of South Elgin for the memory care facility set to open 2018. The facility will have a substantial impact on the District with the number of anticipated calls. He will continue to work closely with the South Elgin. Lightning struck nearby Station 2 during a storm on May 17th which caused problems with the phones and computers. The situation is being evaluated. The Firefighters Association will be hosting a Pancake Breakfast on June 25, 2017 7:00-Noon. Please see the attached Chief Report for complete details
 - c. Attorney's Report: Attorney Ken Shepro gave an update on the Maxxam project and reported the County Board Voted NO on the application. Once the new Trustees have both been sworn in the District will conduct a new Trustee training orientation. Litigation with the IL Dept. of Labor is still ongoing.
 - d. President's Report: President Bob Handley attended the Firefighter's Assoc. meeting and was very impressed. Bob urged everyone to support the Pancake Breakfast. PSSI has agreed to a No Increase contract.
